RESOLUTION OF THE FORESTVILLE WATER DISTRICT ESTABLISHING A RESERVE FUND POLICY

Adopted November 8, 2016 Resolution No. 374

BE IT RESOLVED by the Board of Directors of the FORESTVILLE WATER DISTRICT that it does hereby adopt the following reserve funds policy.

General Reserve Fund

<u>Purpose</u>: The purpose of the General Reserve Fund is to provide the District with resources to guard against service disruption in the event of unexpected temporary budget shortfalls or unpredicted one-time expenditures.

<u>Funding</u>: The General Reserve Fund shall consist of working capital (defined as current assets minus current liabilities) sufficient to provide for a minimum of three months' worth of annual operating expenses and other working capital needs of the annual budget. The General Reserve Fund at no time shall contain more than 12 months' worth of annual operating expenses plus the five (5) year trailing average of the capital improvement plan.

Facilities Reserve Fund

<u>Purpose</u>: The Facilities Reserve Fund shall be funded with connection fees charged in connection with water and sewer services and charges respectively for public facilities. Revenues derived from such charges may be used only for the acquisition, construction, reconstruction of water systems and sanitation, or sewerage facilities, to repay principal and interest on bonds issued for the construction or reconstruction of these water systems and sanitary, or sewerage facilities, and to repay federal or state loans or advances made to the entity for the construction or reconstruction of water systems and sanitary, or sewerage facilities.

<u>Funding</u>: The Facilities Reserve Fund shall be funded solely with water and sewer connection fees and charges respectively for public facilities.
